## INSPECTION OF 8<sup>th</sup> WORTHING SEA SCOUTS - 20 SEP 06

- 1. The inspection commenced at the water activities centre at Southwater Country Park, some 15 miles away from the Group Headquarters in Worthing. Here a selection of the Explorers and Scouts undertook instruction in Kayaking, Canadian canoeing, sailing and pulling. The Groups strength in all forms of kayaking was well demonstrated and it was encouraging to see the recently purchased sailing boats being put to good use, despite the lack of wind.
- 2. This is a good facility which the Group use to full advantage. Experience on other waters is gained at the annual summer camp, this year held at Longridge, and on the annual kayak expedition.
- 3. Since the last inspection the Group successfully undertook a major fundraising exercise and have replaced their kayaks, purchased 6 Topper Taz sailing boats plus a RIB to be used as their safety boat. This has produced a more balanced spread of watercraft from which they can offer a broader set of water experiences.
- 4. The Inspection then continued at the Group HQ where the remaining Scouts, Explorers and Cub Sixers and Seconders were on parade. Representatives from the County Activities team were also present. The Inspecting Officer was piped onboard and Colours held with proper ceremony. The standard of dress was consistently high with the number and range of badges on display showing an active Group with a varied programme. All the young people appeared to thoroughly enjoy their scouting, with those less enthusiastic about the water activities being fully satisfied with the land based programme.
- 5. Due to leadership difficulties the Explorer Unit experienced a dip in its activities and membership last year. A new and most enthusiastic leader has now been appointed and the Unit has experienced a resurgence in the last 6 months with numbers recovering to over 30 members. Most are involved in the DofE award scheme as well as working towards a variety of water qualifications.



- 6. The Group's HQ is a purpose built structure which suits their needs but at over 30 years old is due for a significant refurbishment. Plans to raise the funds and undertake the refurbishment are on hold whilst negotiations continue with West Sussex Education Authority to renew the lease. The outstanding issue is the 12-month termination clause, which the Authority want to include. The Group is understandably loath to undertake major and costly work if they are going to have to resource a new building shortly afterwards. Some external maintenance work is being undertaken using labour provided through a local Probation Service scheme.
- 7. With some 250 youth members the Group is a significant part of the local community and enjoys wide support. They not only successfully participate in District events but also contribute much towards the organisation of those events, including the Worthing Gang Show. They are active members of the RN Scheme, with the Explorers being the current holders of the Soccer Sixes Cup, and some of the Group enjoyed witnessing the Trafalgar 200 Fleet Review from onboard HMS ST ALBANS.
- 8. The sections are well supported by a strong and positive Group Executive. Their deliberately high level of subs and the gift aid scheme cover the annual running costs and they supplement these with major fund raising schemes for specific projects such as replacement of the minibus and, most recently, the renewal and expansion of their fleet of watercraft.
- 9. The Inspection ended with prayers and Sunset, once again conducted with due ceremony.
- 10. The 8<sup>th</sup> Worthing is a very large and well-led Scout Group. Being so large brings a different set of challenges, which they successfully meet to provide a varied, challenging and fun programme for all of their youth members. A longstanding member of the RN Recognition Scheme they maintained their high standards and the Inspecting Officer was pleased to present their Certificate of Recognition to the GSL, Mr Ian Wetherell, after a short address to the Group.
- 11. The Inspecting Officer thoroughly enjoyed this inspection and thanks the Group for their most kind and generous hospitality.
